Following a review of the report submitted and pursuant to Section 3(b) of the Environmental (Impact Assessment and Audit) (Amendment) Regulations, 2019 it has been established that the above proposed project is not likely to have any significant adverse environmental impact and it is hereby exempted from undertaking a Comprehensive Project Report.

The Proposed project is approved to proceed under the following conditions:

1. The proponent should ensure that the quality of water is safe for consumption.
2. Ensure that the proposed activity is approved by the County Government of Wajir and the National Construction Authority prior to commencement of works.
3. Comply with the relevant principal laws, by-laws and guidelines issued for development of such a project within the jurisdiction of the Wajir County government; Ministry of Health, and other relevant Authorities.
4. Ensure that all excavated material and debris is collected, re-used and where need be; disposed off as per the Environmental Management and Coordination (Waste Management) Regulations, 2006.
5. Ensure strict adherence to the provisions of Environmental Management and Coordination (Air Quality) Regulations, 2014 where applicable.
6. Ensure strict adherence to the provisions of Environmental Management and Coordination (Noise and Excessive Vibration Pollution Control) Regulations, 2009 where applicable.
7. Put in place an appropriate traffic management plan that will ensure smooth traffic flow of vehicles on the Town and Estate roads during the construction phase of the project.
8. Ensure that a proper signage is erected on the site clearly indicating the nature of the works taking place on the site.
9. Ensure strict adherence to the Occupational Safety and Health Act (OSHA), 2007.
10. The proponent shall ensure that construction activities are undertaken during the day (and not at night) between 0800 hrs and 1800 hrs; and on Saturday between 0800hrs to 1300hrs. No work shall be undertaken on Sundays; and that transportation of construction material to and from site is undertaken during weekdays and Saturdays only during the hours specified herein.
11. Give appropriate notification to the neighbours to limit the nuisance caused.
12. The proponent shall, if need be, comply with NEMA's improvement orders throughout project cycle.

Operational Conditions

13. Proponent shall, comply with the covid-19 protocol and procedures provided by ministry of Health and sanitations. Dispose off safely the waste negated as a result of corona virus outbreak.
14. Ensure strict adherence to Environmental Management and Coordination (Waste Management) Regulations, 2006 on the issue of liquid and solid waste management.

The above conditions will ensure environmentally sustainable development and must be complied with.
