- 1. The proponent should ensure that the quality of water is safe for consumption.
- 2. Ensure that the proposed activity is approved by the County Government of Wajir and the National Construction Authority prior to commencement of works.
- 3. Comply with the relevant principal laws, by-laws and guidelines issued for development of such a project within the jurisdiction of the Wajir County government; Ministry of Health,
- 4. Ensure that all excavated material and debris is collected, re-used and where need be; disposed off as per the Environmental Management and Coordination (Waste Management) Regulations, 2006.
- 5. Ensure strict adherence to the provisions of Environmental Management and Coordination (Air Quality) Regulations, 2014 where applicable.
- 6. Ensure strict adherence to the provisions of Environmental Management and Coordination (Noise and Excessive Vibration Pollution Control) Regulations, 2009 where applicable.
- 7. Put in place an appropriate traffic management plan that will ensure smooth traffic flow of vehicles on the Town and Estate roads during the construction phase of the project.
- 8. Ensure that a proper signage is erected on the site clearly indicating the nature of the
- 9. Ensure strict adherence to the Occupational Safety and Health Act (OSHA), 2007.
- 10. The proponent shall ensure that construction activities are undertaken during the day (and not at night) between 0800 hrs and 1800 hrs; and on Saturday between 0800hrs to 1300hrs. No work shall be undertaken on Sundays; and that transportation of construction material to and from site is undertaken during weekdays and Saturdays only during the hours
- 11. Give appropriate notification to the neighbours to limit the nuisance caused.
- 12. The proponent shall, if need be, comply with NEMA's improvement orders throughout

## **Operational Conditions**

- 13. Proponent shall, comply with the covid-19 protocol and procedures provided by ministry of Health and sanitations. Dispose off safely the waste negated as a result of corona virus outbreak.
- 14. Ensure strict adherence to Environmental Management and Coordination (Waste Management) Regulations, 2006 on the issue of liquid and solid waste management.
