- 1. This license is valid for a period of **24 months** (time within which the project should commence) from th date hereof.
- 2. The Director-General shall be notified of any transfer/variation/surrender of this license.



Mandatory conditions 3.0 General Conditions

- 3.1. This approval is for proposed De-silting of Usalama Dam and Chemusian Irrigation project on LR. No. Olare/Burnt Forest Block 12 (Usalama Nyakinyuo)/266 in Uasin Gishu County.
- 3.2. The proponent shall provide the final project accounts (final project costs) on completion of construction phase. This should be done prior to project commissioning/operation/occupation.
- 3.3. Without prejudice to the other conditions of this license, the proponent shall implement and maintain an environmental management system, organizational structure and allocate resources that are sufficient to achieve compliance with the requirements and conditions of this license.
- 3.4. The Authority shall take appropriate action against the proponent in the event of breach of any of the conditions stated herein or any contravention to the Environmental Management and Co-ordination Act, Cap 387 and regulations thereunder.
- 3.5. This license shall not be taken as statutory defence against charges of pollution in respect of any manner of pollution not specified herein.
- 3.6. The proponent shall ensure that records on conditions of licenses/approval and project monitoring and evaluation shall be kept on the project site for inspection by NEMA's Environmental Inspectors.
- 3.7. The proponent shall submit an Environmental Audit Report in the first year of occupation/operation/commissioning to confirm the efficacy and adequacy of the Environmental Management Plan.
- 3.8. The proponent shall comply with NEMA's improvement orders throughout the project cycle.

- 4.4. The proponent shall build dykes where appropriate.
