Following a review of the report submitted and pursuant to Section 3 (b) of the Environmental Management (Impact Assessment and Audit) (Amendment) Regulations, 2019, it has been established that the proposed Rehabilitation Of Emarti Water Pan In Matapato North Ward, Kajiado Central Subcounty, Kajiado County, is not likely to have any significant adverse Environmental Impact (s) and it is hereby exempted from undertaking a Comprehensive Project

The Proposed project is hereby approved to proceed with the following conditions:

The Proponent SHALL;

- 1. Seek and obtain authorization to construct the Water Pan from the Water Resources Authority (WRA) and the area Chief before work commences;
- 2. Ensure that the drilled water meets the standards set out by the Environmental Management and Coordination (Water Quality) Regulations, 2006 for Water for Domestic and Agricultural use before commissioning of the Borehole;
- 3. Comply with the relevant principal laws, by-laws and guidelines issued for development of such a project within the jurisdiction of the Kajiado County Government; Ministry of Lands, Housing and Urban Development; Ministry of Transport and Infrastructure; Ministry of Health, National Construction Authority; Directorate of Occupational Health and Safety 4. Ensure that the proposed development or any otwercass of Environment encroach

- 5. Ensure that the excavated areas are backfilled and restored to a state equivalent to the original state or improved;
- 6. Ensure that all excavated material and debris is collected, re-used and where need be; disposed off as per the Environmental Management and Coordination (Waste Management) Regulations, 2006;
- 7. Ensure strict adherence to the provisions of the Environmental Management and Coordination (Air Quality) Regulations, 2014;
- 8. Ensure strict adherence to the provisions of Environmental Management and Coordination (Noise and Excessive Vibration Pollution Control) Regulations, 2009;
- 9. Ensure that, pursuant to regulation 6 (c) of the Water Quality Regulations, 2006, any wetland and/or riparian is protected by ensuring that **NO** development activity is undertaken within the full width of the stream to a minimum of six (6) meters and a maximum of 30 meters on either side based on the highest recorded flood levels;
- 10. Put in place an appropriate traffic management plan that will ensure that there will be no obstruction of vehicle and human traffic during the entire period of the project implementation;
- 11. Ensure strict adherence to the Occupational Safety and Health Act (OSHA), 2007;
- 12. Ensure that construction workers are provided with adequate personal protection equipment (PPE), sanitary facilities as well as adequate training.
- 13. Ensure that construction activities are undertaken during the day (and not at night) between 0800Hrs and 1800Hrs; and on Saturday between 0800Hrs to 1300Hrs. No work shall be undertaken on Sundays; and that transportation of construction material to and from site is undertaken during Weekdays and Saturdays only during the hours specified herein;
- 14. Give emphasis to the control of Dust, Noise, Vibration and Occupational Hazards;

15. Give apprepriate not investion to the neighbors to limit nuisance caused;
